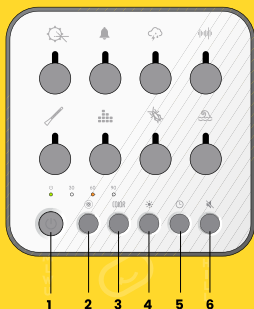


# Sound Machine

## LET'S GET STARTED

1. Your sound machine will come pre-charged, but to make sure it has a full battery, we suggest you charge it again before the first use.

*\*The status light on the face will blink red when charging and turn solid red once charged\**

2. Once fully charged, turn your sound machine on. Mix and match your sounds to get *your* perfect track. Use the sliders for each sound to get precise volume. Crank that beat...and maybe throw some ocean waves in there too.

3. Choose to just let your sounds play or push the timer button to set your sound machine to automatically turn off after 3, 60, or 90 minutes of play time. LED's on the display will tell what you've got it set at.

4. You can even get glowing with the night-light feature. Choose from low, medium, or high white light, solid and pulsating colors, or even color changing.

5. Sit back and relax, do yoga, meditate, take a nap, take a bath, take a breath or just zone out.

6. To make your listening experience private, plug headphones or earbuds into the 3.5mm port on the back of the sound machine.
