- Do not overinflate.








#### How to Inflate

- 1. Open the air valve. Use an air pump to inflate.
- 2. Close the air valve quickly.
- 3. Your unit may include more than one air valve. Fill all chambers before use.
  - · DO NOT overinflate.
  - DO NOT use a high-pressure pump to inflate.








### How to Use the Sprinkler

- 1. Attach a garden hose to the sprinkler by rotating the connector.
- 2. Turn the water on low, and adjust the pressure as needed.

  NOTE: The rubber gasket inside the connector is required to prevent water leakage.



### Storage and Care

- 1. Open the air valve and deflate completely when not in use.
- 2. Dry the item completely before folding and storing.
- 3. Keep in a dry place until next use.

#### **LIMITED 30-DAY WARRANTY**
