Congratulations on the purchase of your SnowCandy® Inflatable. In order to get the best performance from your product, we offer the following recommendations to help increase its longevity and reduce potential damage. SnowCandy® Inflatables are designed using quality PVC materials, allowing the product to perform best when properly inflated. A properly inflated product will expand without distorting the intended shape.

- Inspect the product before each use. Unfold the product on a flat surface before inflating and check for any damage.
- If you encounter any difficulty inflating the product, pinch or squeeze the base of the air valve to ease the flow of air into your inflatable.
- Keep in mind that over-inflation can also cause damage, as this will put stress on the tube seams and may burst. Ideally, inflate the product only until the shape is fairly wrinkle-free.
- If damage is found, and air leakage occurs, please use our included patch kit.
- Do not submerge the product in any liquids
- Keep unit dry when not in use
- Do not jump onto the product
- Do not cut, poke, or try to disassemble the product for any reason
- Do not tow the product with a mechanical or motorized vehicle
- Do not drag the product on a hard or abrasive ground as it may puncture the inflatable
- Do not adhere or apply any hardware or attachments to the product not recommended by the manufacturer

How to Inflate and Deflate your SnowCandy® Realtree® Snow Tube

To Inflate with an Electric Pump

- Open the valve completely, exposing the largest valve opening.
- Insert the large nozzle of an electric air pump into the valve and turn the pump on
- To add smaller amounts of air, open only the top of the large valve, and press a small nozzle of your pump past the flap inside the valve and turn the pump on

To Deflate

- Open the air valve to release the air. Pinch the valve open to speed up air flow
 - For fastest results, use an electric air pump with the hose in the 'Deflate' position.
- Be sure to open the valve completely

Care, Maintenance & Storage

1. Inspect your chair prior to each use.

2. Keep your chair away from sharp objects. Large cuts or snags may not be repairable and will not be covered by your warranty.

3. In case of incidental damage to your chair, a repair kit has been included. Please follow repair instructions carefully as shown on the patch.

4. To clean your chair, use soap and water with a wash cloth.

5. To store your snow tube, make sure it is deflated and completely dry. Store your tube in a clean, dry place at room temperature.

WARNING:

- Adult supervision required for inflation, deflation and maintenance. Follow all safety instructions to avoid serious injury.

• For outdoor recreational use only. Do not use in a pool.

• This tube is not intended for infants or persons with limited mobility.

• Use on flat surfaces only. Do not use this chair on abrasive surfaces or near sharp or pointed objects.

• Keep this tube away from heaters, flames, sparks, or any heat source.

• Do not use this tube while using hot or sharp objects.

• Do not jump on the tube.

CAUTION:

Do not place near sharp objects as this may cause damage to your tube.
