**Red Light Neck Wrap**



## **Instruction Manual**

This product is not a toy. Keep it out of the reach of children and pets.

Thank you for using our Red Light Neck Wrap!

The Red Light Neck Wrap contains a total of 15 LEDs with 660nm and 850nm chips.

**\*You will need a sensor capable of detecting 850nm (a phone camera may work)\***

### 660nm Red Light

Red light is absorbed by skin tissue to support the production of collagen and help optimize skin health.

It also promotes cell metabolism and blood circulation, improving skin elasticity and reducing pallor and dullness.



### 850NM Near Infrared

Invisible to the naked eye, this light deeply penetrates bones, organs and joint to help expand local blood vessels, accelerate blood circulation, increase local arterial blood supply, provide more energy and nutritional support, promote lesion healing and relieve muscle tension, fatigue, and strain.

## Operation

- a. Connect the controller to the head wrap at the rectangular attachment node.
- b. Connect the circular end of the power cable (included) to the controller and the other end to a USB power supply rated 5V / 1A.
- c. Place the product on the desired therapy position of your body and secure it with the Velcro strap.
- d. Press the **Power Button** once to turn the device on (default: "L1").
- e. Press the **+/- Button** sequentially to increase/decrease the light intensity level.
- f. Press the **Timer Button** to set the timer (display will show countdown time).
- g. Press the **Frequency Button** to select either the 10Hz or 40Hz mode (display will show "10H" / "40H").

At the end of the session, the device will turn off automatically.

*Note: Allow the device to cool down for at least 10 minutes before the next treatment.*

## Understanding Frequency Settings

The Red Light Therapy device provides 2 frequency settings: 10Hz and 40Hz, each of which is appropriate for different applications:

- a. 10Hz: Emits pulses of light at 10 cycles per second, commonly used for general relaxation and promoting overall well-being. It is often applied in situations where gentle stimulation and calming effects are preferred.
- b. 40Hz: Emits pulses of light at 40 cycles per second, often used for improving circulation and targeted stimulation. This setting may be suitable for areas where a higher frequency is preferred.

These frequencies offer different approaches to red light therapy, allowing for tailored use based on individual needs.

**● Surface Cleaning Only**

Gently wipe with a soft, damp cloth. Do not submerge in water.

**● Use Mild Detergent**

Clean with a mild soap or alcohol-free disinfectant. Avoid harsh chemicals.

**● Do Not Machine Wash**

Hand-clean only. Do not use washing machines, dryers, or heat-based drying methods.

**● Avoid Bleach & Ironing**

Exposure to bleach or high heat may damage the device.

**● Proper Storage**

Store in a cool, dry place, away from direct sunlight and moisture.

**● Battery & Electronics Safety**

Ensure the device is completely dry before use.

**Warning**

- Operate this device according to manual.
- Avoid exposure or contact with water or moisture.
- Please carefully store the device and accessories when not in use. Keep out of the reach of children; this device is not intended for use by or on children.

For this reason, any individuals with compromised liver or kidney functions should not undergo red light therapy for slimming purposes.
